**Instructions:** Report ALL activity for the permit year (January 1 – December 31). Permit report must be received no later than January 31<sup>st</sup>. Do not submit report before December 31<sup>st</sup> unless all exotic fish have been transferred or sold.

Please provide the following information on the page below:

- **Initial Amount** = Amount of fish in possession at the start of the permit year (Jan 1)
- **Amount imported/purchased** = Amount of fish imported or purchased during the permit year
- **Amount sold/transferred/exported** = Amount of fish sold, transferred, or exported during the permit year
  - Sizes: note what size of triploid grass carp were sold
- **Amount lost / other disposition** = Approximate amount of fish
  - Give brief description of disposition during the permit year (e.g., fish died due to cold)
- **Amount remaining** = Final amount of fish in possession at the end of the reporting period (Dec 31)

**Note:** Effective January 11, 2021, reporting for tilapia is no longer required but transport invoices must still be retained for a period of one year following the sale date and may be requested by the department.
